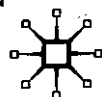

# About the Authors

**Katherine Aaslestad** is Associate Professor of History at West Virginia University. She has published widely on republicanism, civic morality, public memory, and the Napoleonic experience in North Germany, and is the author of *Place and Politics: Local Identity, Civic Culture, and German Nationalism in North Germany during the Revolutionary Era* (Leiden, 2005).

**Howard G. Brown** is Professor of History at the State University of New York, Binghamton. He has published widely on state violence, brigandage, and law and order in France during the Revolution and the Consulate. He has co-edited with Judith A. Miller *Taking Liberties: Problems of a New Order from the French Revolution to Napoleon* (Manchester, 2003), and is the author of *War, Revolution, and the Bureaucratic State* (Oxford, 1995), and *Ending the French Revolution: Violence, Justice and Repression from the Terror to Napoleon* (Charlottesville, VA, 2006).

**Malcolm Crook** is Professor of French History at Keele University. His books include *Elections in the French Revolution: An Apprenticeship in Democracy, 1789–1799* (Cambridge, 1996) and *Napoleon Comes to Power: Democracy and Dictatorship in Revolutionary France, 1795–1804* (Cardiff, 1998). He is the editor of *Revolutionary France, 1788–1880* (Oxford, 2001) and of the journal *French History*. He is working on a history of electoral culture in France since 1789, entitled *How the French Learned to Vote*.

**Gavin Daly** is Lecturer in Modern European History at the University of Tasmania. He has written a number of articles on various aspects of the history of Napoleonic France, and is the author of *Inside Napoleonic France: State and Society in Rouen, 1800–1815* (Aldershot, 2001).

**John Davis** is Professor of History and Director of European Studies at the University of Connecticut, where he also holds the Emiliana Pasca Noether Chair in modern Italian history. He is the general editor of the seven-volume *Oxford Short History of Italy* and editor of *Italy in the Nineteenth Century* (Oxford, 2000). He is about to publish two books

with Oxford University Press: *Naples and Napoleon: Southern Italy and the European Revolutions, 1780–1860* and *Southern Italy since the Enlightenment: A Land without History*.

**John Dunne** is Lecturer in History and Director of Research in Humanities at the University of Greenwich. With Jérôme Decoux he contributed the volume on the Seine-Maritime in the series *Grands notables du Premier Empire* directed by Louis Bergeron and Guy Chaussinand-Nogaret. His current research looks at Napoleonic mayors as intermediaries between the state and the local community. Another ongoing project involves the computerised analysis of the French nobility on the eve of the Revolution.

**Philip G. Dwyer** is Senior Lecturer in Modern European History at the University of Newcastle, Australia. He has published a number of articles on the Revolutionary and Napoleonic eras, is the editor of *Napoleon and Europe* (London, 2001), and has co-edited, with Peter McPhee, *The French Revolution and Napoleon: A Sourcebook* (London, 2002). He is the author of *Napoleon: The Path to Power, 1769–1799* (London, 2007).

**Andreas Fahrmeir** is Professor of Modern European History at the University of Cologne. He has published on the history of migration and nationalism, urban cultures, and the European middle classes. He is co-editor, with Olivier Faron and Patrick Weil, of *Migration Control in the North Atlantic World* (New York, 2003), and author of *Citizens and Aliens: Foreigners and the Law in Britain, and the German States, 1789–1870* (New York, 2000). His most recent book on the political elite of the London City Corporation is *Ehrbare Spekulanten: Stadtverfassung, Wirtschaft und Politik in der City of London (1688–1900)* (Munich, 2003).

**Alan Forrest** is Professor of Modern History at the University of York. He has published widely on French revolutionary and Napoleonic history, especially on social history and on the military. His most recent publications include *Napoleon's Men: The Soldiers of the Revolution and Empire* (London, 2002); *Paris, the Provinces and the French Revolution* (London, 2004); and (jointly authored with Jean-Paul Bertaud and Annie Jourdan) *Napoléon, le monde et les Anglais. Guerre des mots et des images* (Paris, 2004).

**Alexander Grab** is Professor of History at the University of Maine. He has published widely on the army, law and order; and finances in

Napoleonic Italy. His most recent publications include 'From the French Revolution to Napoleon', in John Davis (ed.), *The Risorgimento and Unification 1789–1796* (Oxford, 2000); and *Napoleon and the Transformation of Europe* (Basingstoke, 2003).

**David P. Jordan** is Distinguished Professor of French History at the University of Illinois, Chicago. He is the author of *The King's Trial: The French Revolution vs. Louis XVI* (Berkeley, 1979), *The Revolutionary Career of Maximilien Robespierre* (New York, 1985), and *Transforming Paris: The Life and Labors of Baron Haussmann* (New York, 1995). He is working on *Napoleon as Revolutionary*.

**Ute Planert** is Lecturer in Modern European History at the University of Tübingen. She has published widely on the relationship between anti-Semitism and anti-feminism, racial hygiene, German nationalism in the long nineteenth century, and the experience of the French Revolutionary Wars in the Holy Roman Empire and the Confederation of the Rhine. She has edited *Nation, Politik und Geschlecht: Frauenbewegungen und Nationalismus in der Moderne* (Frankfurt/Main, 2000) and is the author of *Antifeminismus im Kaiserreich: Diskurs, soziale Formation und politische Mentalität* (Göttingen, 1998). Her most recent work includes *Der Mythos vom Befreiungskrieg. Frankreichs Kriege und der deutsche Süden, 1792–1841. Alltag, Wahrnehmung, Deutung* (Paderborn, 2006).

**Michael Rowe** is Lecturer in Modern European History at King's College, London. He has published on various aspects of Napoleonic rule in Germany, including most recently 'The Napoleonic Legacy in the Rhineland and the Politics of Reform in Restoration Prussia', in David Laven and Lucy Riall (eds), *Napoleon's Legacy: Problems of Government in Restoration Europe* (Oxford and New York, 2000). He is the editor of *Collaboration and Resistance in Napoleonic Europe: State Formation in an Age of Upheaval, c. 1800–1815* (Basingstoke, 2003), and author of *From Reich to State: The Rhineland in the Revolutionary Age, 1780–1830* (Cambridge, 2003).

**Michael Sibal** is Associate Professor of History at Wilfrid Laurier University in Waterloo, Ontario, Canada. He has published numerous articles and essays on the nineteenth-century French labour movement, the Napoleonic police, and the history of French homosexuality. He is working on a book on the Napoleonic police state.
