**Marco Bunte** is a Senior Research Fellow at the Institute of Asian Studies in the German Institute of Global and Area Studies (GIGA) in Hamburg, Germany. His main research interests lie in the field of comparative politics, especially in democratization, decentralization and political violence. Bunte has been lecturer for Southeast Asian politics at the University of Helsinki and for comparative politics in Hamburg and Münster University. He obtained his PhD from the University of Münster in Germany in 2002 with a dissertation on regional autonomy in Indonesia (*Regionale Autonomie in Indonesien*, Hamburg, Institute of Asian Affairs 2003). In conjunction with this he carried out fieldwork in West Sumatra and Central Java for seven months in 2001/2002.

**Christian Chua** received his PhD in Sociology from the National University of Singapore. He currently works as organizational development expert for Deutsche Bank and lectures at the Humboldt University Berlin and Frankfurt University.
